MINUTES

CALL TO ORDER

The Board of Equalization Hearing was held on Tuesday, April 27, 2021, via video conference in Dillingham, Alaska. Mayor Alice Ruby called the meeting to order at 5:30 p.m.

ASSESSOR'S COMMENTS

<u>Arne Erickson</u>: Overall the City looks good. A complete re-inventory will be started late summer. Converting from hard cards to an electronic system is ongoing. The records are in good shape. Overall property owners appear to be satisfied with assessments and the appeal process. Sales vs. assessed values are in a good range. Property values have increased slightly, this will be addressed with the re-inventory to verify valuations. Process used for assessment this year – based on new construction and apply standardized manual used unit valuation worldwide, applying a local building cost multiplier, lifetime depreciation schedules, deeds of trust, and actual visual assessment when needed. Goal is to reflect true market value.
