- Requested Council to amend Resolution 2023-11 to 1.7 million
- Covid has affected the students' learning.
- Activities inspire kids to do better in school to continue participation.
- Dillingham community thrives around activities.
- Activities and Sports are where students lose labels and backgrounds.
- Some activities are teaching trade skills to be used after high school to obtain employment.
- This year 75 students are involved in music activities, (35% of DCSD population)
- Sports and extracurricular activities are vital to the mental, emotional, and physical health of the students.
- Teachers are critical and retaining teachers should be a top priority. Dillingham is already at a disadvantage with recruiting, with salaries and, lack of housing.
- DCSD will be losing their grant writer in June, grants are able to fund core curriculums not salaries.
- College applications are stronger with extra curriculars and sprots.
- Estimated 7.5 credits lost if funding isn't provided.
- If cuts are made at the school, there is the possibility of families leaving Dillingham for their children.

## Support of Increasing to 1.7 million:

- Noted unclear if waiting a few months would change the overall picture of the budget.
- Stated that 1.7 million is not out of the City's means.
- Expressed was sympathetic to the issue.

- A compromise of 1.55 million to meet in the middle, but stated would go for 1.7.
- Stated the City has given more than statutorily required for many years.
- Clarified that even if 1.7 million was approved, that does not guarantee activities and sports won't be cut. The City does not have authority over the DCSD budget.

## Opposing Increasing to 1.7 million:

- Clarified that if 1.7 million was not given it is not due to lack of care for the children.
- Noted over the last two years the City budget took a hit to ensure that the school was held stable.
- Noted the City has postponed items that need to be addressed i.e..
  - o Pay scales.
  - o Housing Issue
  - Facility Maintenance and Upkeep
    - Road Maintenance
- Discussed how City Capital Projects supports the residents, and the residents have the children who attend the school.
- Stated that the responsibility of keeping sports and extracurricular activities present in school did not fall on the Council alone.
