- Council agreed the workshop would be self-facilitated and focus on priorities, criteria, timeline, and whether to use a third-party consultant.
- Consensus reached to hold the workshop on January 8, 2026 at 5:30 p.m., immediately prior to the rescheduled regular/special council meeting.

Extended holiday greetings to the community.


