A RESOLUTION OF THE DILLINGHAM CITY COUNCIL AUTHORIZING THE CITY MANAGER TO WAIVE THE PROCUREMENT REQUIREMENTS TO AWARD A CONTRACT TO JJC ENTERPRISE INC. FOR REPLACEMENT OF THE OUTFALL STORM DRAIN PIPE

WHEREAS, the outfall storm drain pipe is past its useful life and no longer operating properly to move water through the storm drain system; and

WHEREAS, during heavy rains, and snow melt flooding in the downtown area occurs due to the condition of the existing storm drain pipe; and

WHEREAS, for safety concerns the city desires to decrease the possibility of roadway flooding; and

WHEREAS, JJC is currently mobilized for downtown streets construction; and

WHEREAS, the City will realize cost savings efficiencies as well as gaining local project knowledge by retaining JJC for this project; and


WHEREAS, waiving the purchasing restrictions is based on criteria outlined in DMC 4.30.130, Exemptions B. 4, The services or are of a professional nature requiring specialized knowledge and judgment; and

NOW, THEREFORE, BE IT RESOLVED the Dillingham City Council waives the purchasing restrictions as stated above contract with JJC Enterprises Inc. for replacement of the outfall storm drain pipe in an amount not to exceed \$72,300;

PASSED and ADOPTED by a duly constituted quorum of the Dillingham City Council on August 12, 2021.

We have taken a close look at the replacement of the outfall storm drain pipe from Barge Access Road. to the river. JJC is proposing to install 18" CPP for a lump sum price of \$72,300. This would include all labor, equipment & materials to perform the work. The anticipated amount of pipe to be installed is roughly 300'. There are a couple crossings of electrical that would need to be accounted for. With the finished installation, JJC will provide as-builts for line and grade. Should our proposal be accepted, we will coordinate with the city dock as to the best time to perform this work. Thank you for the opportunity to provide this proposal.
