BE IT FURTHER RESOLVED that the April 10, 2012, Special City Election was held valid to the best of our knowledge.


BE IT FURTHER RESOLVED that the results are certified as follows:


1. Proposition No. 1, Annex Commercial Fishing Waters passed having received the greatest number of votes cast.





Summary Statement.

Resolution No. 2012-23 – At the April 19 council meeting, Resolution No. 2012-20, Certifying the Election, was amended to change the total number of poll ballots correctly cast from 658 to 654. This recommendation from staff was an error and will be reversed with Resolution No. 2012-23 adopting the corrected number of poll ballots properly cast, 658 (~~654~~), and the total ballots properly cast, 727 (~~723~~), as originally presented and will include repeal language to repeal Resolution No. 2012-20.
