

BE IT FURTHER RESOLVED that the results are certified as follows:


1. That Chris Napoli was elected to Council Seat A, a one year term ending October 2019, having received the greatest number of votes cast for this seat.

7. That Bernina Venua was elected to School Board Seat E, a three year term ending October 2021, having received the greatest number of votes cast for this seat.
